The guest or tour operator hereby indemnifies Sashwa ROS and all its directors, servants or agents of the tour operator in respect of such personal injury, loss or damage.

Insurance

It is essential that guests have sufficient travel insurance prior to arrival to cover medical costs, emergency evacuation, repatriation, loss or damage to personal belongings and cancellation.

Guests are required to sign an indemnity form on arrival.

Children

Children over 16 years are welcome at Sashwa River of Stars. A single child accommodated in their own suite will attract the full single adult rate. Children of all ages are welcome for exclusive use group bookings. Please note that there is an unfenced swimming pool.

BOOKING POLICY:

All reservations, cancellations & amendments to be made with Sashwa ROS in writing.

All refunds will incur a 3% admin charge on the total amount refunded to cover processing costs.

Sashwa ROS works on an Automatic Release System on all provisional bookings. If no prior contact is received from the guest to release, confirmed (with deposit) or request an extension of the booking, the space may no longer be available and Sashwa ROS will not be responsible for the re-instatement of the booking.

Reservations will be held for 48 hours from date of booking.

Deposit Policy:

Upon confirmation of the booking, a 20% non-refundable deposit is required.
45 Days prior to arrival, full pre-payment is due.

Cancellation Policy:

Cancellations must be received and acknowledged by Sashwa by electronic mail
20% cancellation applies if cancelled 45 days or more prior to arrival
100% cancellation if cancelled within 45 days of arrival.

Payment Terms:

All payments to be received promptly as stated in the deposit policy, should payments not be forthcoming, Sashwa ROS reserves the right to cancel the reservation.

Proof of payment must be sent to the Reservations office with the reservation number and name clearly stated on the correspondence.

Payment for all additional services at the lodge and all items of a personal nature must be settled on departure by the guests.

Any third-party services that are booked by Sashwa ROS are subject to full pre-payment to secure.
